ELECTION OF PARENT GOVERNOR – VACANCY NOTICE

We currently have one Parent Governor Vacancy at our school and we are looking for nominations from parents to fill this vacancy.

What are Governors?

Governors make decisions about how our school is run and they have legal duties, powers and responsibilities. The Governing Body meets at least once a term at school, usually in the evening. Sub committees are set up sometimes to deal with specific issues and sub-committee meetings will be arranged as necessary. All Governors are provided with help, training and support by Flintshire County Council, and there is online help too.

Parent Governors

To be eligible for nomination, Parent Governors must have a child at our school and only other parents can make nominations. The term of office for all Governors is four years (or until resignation) and they may be re-elected. All Governors have equal status and voting rights.

How to nominate a parent for election as Parent Governor

Nominations must be made on the attached nomination form, seconded by another parent and signed by the nominated person. The completed form should be returned to me, as Acting Returning Officer, no later than **4:00pm on Wednesday 24th October 2018.**
